60th ANNIVERSARY BPW-UN

The International Federation of Business and Professional Women gained consultative status with the United Nations in the year 1947. So this year, 2007, marks the 60th Anniversary of our consultative status at the United Nations. BPW International celebrated this 60th Anniversary in New York during the Commission on Status of Women 51st Session with a dinner celebration on 2 March 2007 and the BPW Panel session at the United Nations Headquarters on 5 March 2007, at which we have distinguished speakers from BPW Italy, Egypt, Brazil, New York. The most notable speaker is Dr. Rita Levi Montalcini, a Nobel prize winner and a member of BPW Italy.

This 60th Anniversary is also a good time to celebrate past accomplishments.

- The new version of the web site www.bpw-international.org was launched on 14 February 2007. New sections includes online version of BPW International History books, projects, awards sections.
- BPW International Anthem, composed by Professor Consuelo Amador de Rivera, was re-mastered and re-launched at North America and Non-Spanish Speaking Countries Regional meeting in the Caribbean in Jamaica on 17 February 2007,
- The book *Empowering Women Worldwide: The History of Project Five-O*, written by Sylvia G. Perry, was launched on 24 February 2007.
- The Dr. Silvia Salazar Salazar School of Nursing in La Paz, Mexico, celebrated its 15th Anniversary. The effort of BPW world-wide in starting and supporting this school is told in Chapter 7 of Project Five-O history book, which is also posted on the new web site.

This 60th Anniversary is also a good time to plan for the future. To continue to have this consultative status, BPW International has to report to the UN every 4 years on our activities with the UN and how our organization contributes to UN mandate, especially Millennium Development Goal. The UN Reform may have significant impact on the relationship between Civil Society and the UN.

I hope you enjoy this special issue of the BPW International newsletter and join in the celebration of 60th Anniversary of BPW consultative status at the United Nations.

Commission on Status of Women 51st Session

BPW Caucus

About 230 BPW members from 34 countries attended Commission on Status of Women (CSW) 51st Session in New York. BPW held a caucus to work on key issues to lobby for changes the draft document of CSW 51st session. Two key things were finalized. The first is to add the text to indicate that teaching self-defence to women should be used to prevent violence against women. The second is to ensure that in rehabilitation victims of gender based violence require comprehensive programmes for physical, psychological, economic and social recovery. Members were asked to lobby the government delegates from their countries on these two points.

Celebrating 60th Anniversary BPW-UN

BPW members celebrated the 60th Anniversary of our consultative status with the United Nations with a delicious cake during BPW International Dinner on Friday 2 March 2007. At this same event, BPW Moscow presented Antoinette Ruegg and President Chonchanok Viravan with Silver Medals, a Peace Award from Russia for BPW International in recognition of BPW International's work world-wide for Peace. We also publicised "Empowering Women Worldwide", the history of Project Five-O, written by Sylvia Perry. 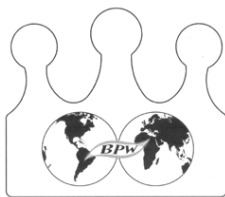

BPW Panel on Violence Against Women: Urgent Issues and Solution

On 5 March 2007, BPW International and the Ministry of Foreign Affairs of Italy held a Panel Presentation inside the United Nations Headquarters in New York, in parallel to Commission on Status of Women 51st Session. We had many distinguished speakers including a Nobel Prize Winner Dr. Rita Levi-Montalcini (BPW Italy), Anita Palmeri (BPW Italy), Talia Carner (Award winning author of Puppet Child and China Doll - BPW Manhattan, New York), Beatriz Fett (President of BPW Brazil) and Dr. Amany Asfour (President of BPW Cairo, Egypt).

We had a room filled with an audience of over 200 people! Many issues on violence against women and the girl child were discussed through the work of Dr. Rita Levi-Montalcini helping over 12,000 children, and the problem of infanticide in China. The solutions presented include the promotion of the Bill of Rights of the Girl Child by BPW Italy, Maria da Penha Law – the new legislation about violence against women in Brazil and the ways to gain financial independence in order for women to break free from their abusers. Annarosa Colangelo, Chair of UN Committee for BPW International, did a splendid job in arranging the venue within the UN. 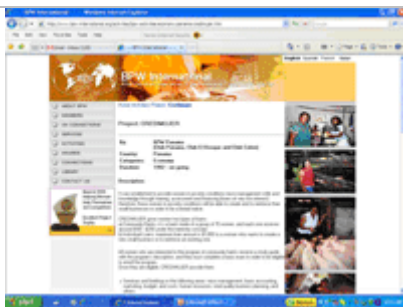


Projects: Each member country can submit projects to be posted on BPW International's Projects page. Links to projects will also appear in the Country page.

New BPW Pay Online

BPW Affiliates can pay their International dues and Friends donation with credit cards and PayPal.

Basic flow for making BPW Online payment is as follows:

1. Identify Payer

- Payer of International dues must specify Affiliate ID.
- Friends who want to renew should specify Friends ID.

New friend can pay without having to specify ID. The system may ask for a few more details, such as Affiliate name or Friend name.

2. Specify amount and currency: Payment is accepted in EURO, GBP or USD.

3. Confirm payment information: A screen with summary of payment information will appear for you to verify payment information. If it is correct, click PayPal Payment

4. Make Payment: PayPal Payment page will have 2 options for payment method: Pay via PayPal account or Pay by credit cards.

- If you are a PayPal member, you can log in and make the payment.
- If you are NOT a PayPal member, you can pay by Visa, MasterCard, American Express,

5. Get Receipt: After payment is complete, you will see a payment completion page. You will also receive a receipt via e-mail. BPW International will also get an e-mail notification of your payment.

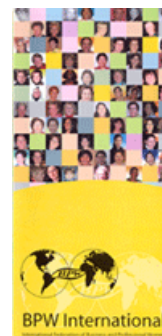
For International dues, official receipt and Certificate of Affiliate will be issued to your club / Federation after the payment is verified. For Friends payment, Friend's cards will be issued after the payment has been verified.

Relaunch BPW Anthem

One of the best kept secrets of BPW International is that we have BPW International Anthem! The anthem has been re-mastered and is available in CD format. Let's start a tradition of playing BPW International Anthem at the beginning of BPW International events!

History of the Anthem

BPW International Anthem was composed by Professor Consuelo Amador de Rivera. It was originally composed as National Anthem for BPW Mexico in 1984 with lyric in Spanish. At the 21st BPW International Congress in Nagoya, Japan in year 1993, a resolution was passed to adopt the anthem as BPW International Anthem. The anthem was played at the 22nd BPW International Congress in Venice, Italy. Yet, most affiliates are not familiar with it. As a part of branding in Organization Reform process, President Chonchanok Viravan decided to have this anthem re-mastered and redistributed. The first version, released at North America Regional Conference in Jamaica, February 2007 was re-mastered based on the old tape recording of the anthem. However, the anthem was revised with respect to the actual music notes after President Chonchanok met and received the notes from Professor Consuelo in March 2007.

PACKAGE FOR BPW AFFILIATES:

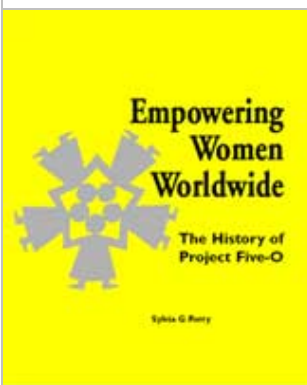

PROJECTS

Launching History of Project Five-O book

A quarter of a century of activity and achievement on behalf of women in developing countries has been told in *'Empowering Women Worldwide, the history of Project Five-O'*, the special partnership of five major women's organizations, the International Federation of University Women, the International Federation of Business and Professional Women, the International Council of Women, Soroptimist International and Zonta International.

The partnership of Project Five-O was agreed and launched formally when they met in Copenhagen in 1980 for the Mid-Decade Conference after the UN First World Conference for Women in Mexico and the launch of the International Decade for Women in 1975. Their then combined membership was 75 millions in 75 countries. Initially, the Associated Country Women of the World was one of the five but left the partnership in 1987 and was replaced in 1991 by Zonta International. All shared a common goal, the desire to help disadvantaged women become educated and economically empowered.

A conference in Copenhagen in 2005 was part of the celebrations marking the first 25 years. The second was to produce a written history of this time with sponsorship by DANIDA, the Danish International Development Assistance. Sylvia Perry, a former president of BPW International, took on the challenge of writing the book, *'Empowering Women Worldwide'*, the story of women who deserve to be remembered for posterity. While the book is foremost the historical record of the first 25 years of Project Five-O, it also brings to life, the stories about each project, introduces some of the outstanding women who have made the vision of the initial Five-O presidents a reality and salutes the achievements of the five organizations for their continuing interest and support.

The books and CD versions are available for sale to raise funds for further worthwhile projects. The book can be ordered from BPW International President's office at 15 USD plus shipping and handling. For each book sold, BPW International will donate the profit to the Project Five-O fund, which is used to support women capacity building projects, which are managed locally by at least 2 out of 5 organizations in Project Five-O partnership.

In Kofi Annan's words "There is no tool for development more effective than the empowerment of women" and Project Five-O has fulfilled, is fulfilling and hopefully will continue to fulfill that mission for the next 25 years.

The celebration was organized by the authorities of the CONALEP , Government Professional Education Institution, which is in charge of the School. Attending as BPW guests of honor were our International President Dr. Chonchanok Viravan, Mrs. Liz Benham Second Vice President, Susan Jones Chair of Projects Committee, Professor Ma. Silvia Salazar Salazar International Coordinator of the Nursing School, Yasmín Darwich Chair of the Public Relations Committee, Mrs. Ryna Leonor Geraldo Fiol President of the La Paz Club with the Club members and Mrs. Rafaela Vizcaíno of the Cd. Constitution B.C.S. Club. At the event were the State Director of the CONALEP, Lic. Lino Renan Villavicencio Garayzar, Lic. Teresa Camacho Barajas Director of the School, Lic. Ricardo Pérez Rasura President of the H. Board of Directors, the authorities of the State and Municipal Government and the Directors of the Health Institutions in the State of B.C.S., and all the students and teachers.

During the ceremony, Dr. Viravan gave a very touching speech and distinguished the State Director of the CONALEP by naming him "Honorary Member" of BPW International, as recognition for the great support that he has

given us from the beginning of the Project. She also gave a special recognition to Professor Consuelo Amador de Rivera for being the composer of the Anthem of BPW International and donated the copy rights of it in 1993 during the International Congress in Japan, and to the Professor Ma. Silvia Salazar for her extraordinary work since 1985.

The presence of our International Executive authorities encouraged the State and Municipal Governments to continue granting their support to finish the construction of the Auditorium "Dr. Yvette Swan " which will be of great use and benefit for the students and for the whole community of La Paz.

The CONALEP granted recognition to those who have worked for the School from its opening. Dr. Viravan received the one for BPW International. Prof. Ma. Silvia Salazar Salazar, Dr. Yasmín Darwich and the La Paz Club members also received recognitions. After the Ceremony the CONALEP offered a traditional Mexican dinner. The students joyfully received the scholarships contributed by the BPW Australia Joondulup Club, Liz Benham and the Darwich family. The BPW Club Central Coast, Australia sent a donation for the construction of the Auditorium.

It was a very productive visit, full of satisfactions and new expectations to continue working on one of the most important projects of BPW International. We invite all members to join with their contributions to finish the construction of the Auditorium and provide more scholarships for the students.
