Applications will only be considered if the affiliate of which the nominee is a member has paid their dues for the year ending 31st December 2008, together with any outstanding dues, by the first day of Congress.

The President of their Federation or Associate Club will be asked to endorse their application.

Article VII Section 3 of the By-Laws provides that no Committee Member shall serve for more than two (2) consecutive terms in the same capacity.

A candidate shall not accept nomination for more than 1 office except as provided in Article 3, Section 1 of the By-Laws. Candidates for Standing Committees are expected to be committed to further the objectives as laid out in the Guidelines for Standing Committees.
